

## **DMP Law Corporation Website Privacy Policy**

DMP Law Corporation (“DMP Law”) is committed to your right to privacy. This Website Privacy Policy (“Policy”) governs the collection, processing, and possible transfer of personal information collected in connection with DMP Law’s website, available at: [www.dmplawcorp.com](http://www.dmplawcorp.com) (the “Site”). The Policy applies to each person accessing or using the Site and/or services provided on the Site (“Services”). The Site is a professional services website. If you choose to use the Site, the Services, or otherwise provide personal information to DMP Law through the Site, you explicitly consent and agree to DMP Law’s use of such information in accordance with this Policy. You should not use the Site or Services or submit any information through them if you do not agree to any of the terms herein. This Policy shall not be construed in any manner to derogate from DMP Law’s Terms of Use or any other agreement or understanding between DMP Law and you.

### **Confidentiality**

If you are not a current client of DMP Law, do not include any confidential, secret or otherwise sensitive information in communications with DMP Law. Unsolicited e-mails and information sent to DMP Law will not be considered confidential or secret, may be disclosed to others, may not receive a response, and do not create an attorney-client relationship with DMP Law.

### **Collection Of Your Personal Information**

You may be required to provide certain personal information to DMP Law when you elect to use the Services. In order to better provide you with services and/or products offered on the Site, DMP Law may collect personally identifiable information that you provide, such as your:

- First and Last Name
- E-mail Address
- Phone Number
- Mailing Address

DMP Law will use your information for, but not limited to, communicating with you in relation to services and/or products you have requested from DMP Law. DMP Law also may gather additional personal or non-personal information in the future.

### **Use Of Your Personal Information**

DMP Law collects and uses your personal information to operate the Site and deliver the services and/or products you have requested. DMP Law may also use your personal information to inform you of other services and/or products available from DMP Law and its affiliates.

### **Sharing Information With Third Parties**

DMP Law does not sell, rent or lease your information to third parties. DMP Law may share information about you with trusted partners to perform services for DMP Law, including helping perform statistical analysis, sending you email or postal mail, providing customer support, arranging for deliveries, providing bookkeeping, tax, and accounting services, web hosting, or for other purposes.

DMP Law may disclose your personal information, without notice, if required to do so by law or in the good faith belief that such action is necessary to: (a) comply with the law or legal process served on DMP Law or the Site; (b) protect and defend the rights or property of DMP Law; and/or (c) act under exigent circumstances to protect the personal safety of users of DMP Law or the public.

### **Automatically Collected Information**

Information about your computer hardware and software may be automatically collected by DMP Law. This information can include your IP address, browser type, domain names, access times, and referring website addresses. This information is used for the operation of the Services, to maintain quality of the Services, and to provide general statistics regarding use of the Site.

### **“Do Not Track” Technologies**

DMP Law does not respond to web browser “Do Not Track” signals.

### **Security Of Your Personal Information**

DMP Law takes measures to secure your personal information from unauthorized access, use, or disclosure. DMP Law uses Secure Sockets Layer (“SSL”) protocol for this purpose. When personal information is transmitted to other websites, it is protected through the use of encryption, such as SSL protocol.

DMP Law strives to take appropriate security measures to protect against unauthorized access to or alteration of your personal information. Unfortunately, no data transmission over the Internet or any wireless network can be guaranteed to be 100% secure. As a result, while DMP Law strives to protect your personal information, you acknowledge that: (a) there are security and privacy limitations inherent to the Internet which are beyond DMP Law’s control; and (b) security, integrity, and privacy of any and all information and data exchanged between you and DMP Law through this Site cannot be guaranteed.

### **Your Privacy Rights**

Depending on the country where you are located, you may have the following rights in connection with information DMP Law collects about you:
